



## FOOD VENDOR CONTRACT

Operation Pride Inc. of Council Bluffs, Iowa hereby agrees to lease to \_\_\_\_\_ (“Vendor”) one food booth space for the purpose of retail sale of food to the public during the Taste of Council Bluffs activities associated with the Celebrate CB - on Friday, May 8<sup>th</sup> and/or Saturday, May 9<sup>th</sup> 2009. Hours of operation are 11:00 a.m. – 9:00 p.m. CST.

Vendor does hereby agree to pay Operation Pride, Inc. the sum of \$75.00 as a non-refundable deposit to lease one food booth space. If vendor would like a 10’x10’ tent/cover, please add additional \$60.00. Deposit is due on or before April 21, 2009. Our address is Operation Pride Inc. P O Box 1544, Council Bluffs, Iowa 51502.

Vendor hereby agrees to obtain all permits from the Health Department for the sale of food. There is a \$33.50 application fee for the health inspection as a temporary food establishment license. Groups providing a 501(c)3 license are exempt from said fee, but the application must be submitted. All food booths will be inspected and approved by the Council Bluffs Health Department prior to selling any food or drink. A copy of said inspection shall be posted within the food booth during all hours of operation. Vendor of said inspection shall be posted with the food booth during all hours of operation. Vendor shall also be required to provide proper clean up to its food booth area upon completion of the Celebrate CB event. (If vendor has a state mobile food license they are exempt from obtaining the temporary food establishment license.)

Vendor will either bring a trailer/truck and will serve park side or have a free standing booth in the park. Street side will be blocked from use. No trucks will be allowed to drive into the park area.

Vendor will furnish to Operation Pride Inc. a copy of a Certificate of Insurance for liability purposes. Said certificate shall list Operation Pride Inc. and the City of Council Bluffs as additional insureds. Operation Pride Inc. will be free from any liability for any claims for damages or injuries arising from operation of the food booth or from products sold by Vendor.

Vendor shall provide any personnel, supplies, tables and/or booth structure necessary for the purpose of selling foods to the public. Vendor should consider providing sample items on the menu also.

Advertising, marketing and promotion for Celebrate CB! and its Vendor(s) and Sponsor(s) will be supplied by Operation Pride Inc. Vendor may purchase supplemental advertising to promote sales of its good before and/or during the Celebrate CB! event. Vendor may display any banner or logo to identify its food booth. Said banner or logo shall be located on or inside Vendor’s designated food booth space.
